

# 2010 Arts and Crafts Fair

The Southern Door Athletic Booster Club is sponsoring the 30th annual Arts and Crafts Fair on Sunday, November 7th 2010, from 9:00 AM to 3:00 PM. The fair will be held at Southern Door School, 2073 Cty Rd DK, Brussels, WI 54204, 8 miles north of Brussels (Old Hwy. 57). The fee for an approximate 80 sq. foot booth and chair is \$45.00. There is an additional charge of \$8.00 per table rental, and \$6.00 electrical charge if needed. NO MANUFACTURED PRODUCTS WILL BE ALLOWED. MAKE CHECKS PAYABLE TO: SOUTHERN DOOR ATHLETIC BOOSTER CLUB.

## **As an Exhibitor you will agree...**

1. Upon arrival to check in at the front desk for your booth location and closest entrance in which to bring in your goods.
2. To be responsible for setting up your booth between 6:00 AM and 9:00 AM on the day of the event and OPERATE IT UNTIL 3:00 PM (We will also have a set up on the Saturday before the craft fair from 11:00 AM to 2:00 PM, for any crafter who would like to set up early. The School will be locked after 2:00 PM until set up time on Sunday. The Southern Door Booster club and Southern Door Schools will not be responsible for any theft or damage done to exhibitor's materials). All spaces must be cleared of litter and have tape removed from floor. Any one not here by 8:00 AM, without a call 24 hours prior, will forfeit the space and all fees paid. The space will then be resold.
3. To provide any necessary identification signs and banners. Projection of any signs or equipment into the isles or walkways will not be permitted including tents or frames larger than 8x10. All table tops and exposed sides must be covered with a cloth.
4. Not to damage booth materials, walkways, floor or any part of the building. Exhibitors will be responsible for any such damages.
5. No smoking, no consuming or dispensing of beer, liquor or other alcoholic beverages in the building or on the premises. Smoking and alcohol in school or anywhere on school property is a violation of state law. WI stats. 101.123. Minimum fine \$120.30. The Exhibitor will be allowed to have food and/or beverages in their booth.
6. To park your vehicle in the back parking lot on the south side of the school after unloading or other designated areas indicated at the time of check in. DO NOT EMPTY ASHTRAYS ON THE BLACKTOP OR LEAVE ANY GARBAGE BEHIND.

## **As the sponsor, the Southern Door Booster Club agrees...**

1. To provide reasonable security service. However, the club is not responsible for the theft, damage or loss of an exhibitor's materials or injury to an exhibitor unless caused by negligence of the club.
2. To no other liability other than the refunding of rental fees should cancellation of the Arts and Crafts Fair be necessary. Rental fees are not refundable in the event of the Exhibitors cancellation. We reserve the right to limit or refuse the number or type of craft.
